

Eligibility/ Kritè elijibilite

1.

Q: Would the cash flow and profitability requirement be a major disadvantage for local companies vs. foreign companies?

A: Local versus foreign could relate to ownership or registration. With regard to registration, we will view local versus foreign companies differently as addressed in the next question. With regard to ownership, we do not view local versus foreign ownership as being a likely key driver of potential profitability. If two companies are registered to operate in Haiti with operations in country, the one with foreign ownership may ultimately have a greater ability to access capital, but this should not affect the ability of both companies to project similar profitability assuming they are able to access the capital they require to execute their growth plans.

That said, we recognize that there may be a limited number of cash flow positive and profitable businesses operating in Haiti in this space due to the current political unrest, however applicants should be able to demonstrate in their applications their path to sustained enterprise growth, and sustainability and profitability, in the near- or medium-term future, notwithstanding external shocks such as political turmoil.

Q: How will you prioritize local companies vs. foreign companies given profitability and cash flow requirements knowing the current & past social and economic issues in the country?

A: Companies registered in Haiti will be prioritized. There is a separate funding window for foreign companies which are not registered in Haiti but that have an interest in entering the Haitian market or partnering with a Haitian-registered company to manufacture, distribute, or retail or otherwise enable the delivery of clean cooking solutions in Haiti on a commercial basis. They can apply to receive funding to conduct feasibility assessments or pilots to gauge market readiness or to explore partnership opportunities to manufacture or distribute products.

R: Konpayi lokal ki anrejistre an Ayiti ap gen priyrite. Gen yon finansman pou konpayi etranje yo ki diferan de finansman pou konpayi lokal yo. Gen yon finansman ki ap pou konpayi etranje ki enterese antre nan mache ayisen an oswa pou yo fè patenarya ak yon konpayi ayisen lokal pou yo ka fabrike, distribye, oswa vann pwodwi ki pote solisyon pwòp pou moun ka fè manje. Konpayi yo ka aplike pou yo resevwa finansman pou fè evalyasyon oswa pilòt pou mezire si pwodwi yo prè pou antre nan mache a oswa pou yo chèche opòtinite patenarya pou fabrike oswa distribye pwodwi yo.

Q: Can multiple companies work together to submit one proposal?

Q: We have separated our business into two entities: a distribution company and a manufacturing company. Both have different shareholders. Can they each submit a proposal?

A: Yes, each can submit a proposal, but each application should be for different uses of funds. We may elect to encourage such applicants to combine their applications into one project proposal later in the process, to be determined depending on particular circumstances.

Q: Regarding the geographic zones, should the enterprise be able to cover all the areas listed in the project?

A: No, the enterprise does not have to be operating in those areas. The project is open to all areas where there can be a positive impact.

Q: What are the benefits if a company already has carbon finance certification?

A: If the company identifies carbon finance as one of its needs and is selected, we can potentially support it to expand on or growth the existing carbon finance program.

Q: Is there a component of the project that will focus on consumer financing?

A: Yes, as part of the proposed use of funds, companies can apply to develop consumer financing pilots or increase the scope or scale of existing consumer finance pilots.

Q: We distribute improved (coal-fired) stoves and gas stoves, do you have a preference for one of these types of stoves in the Program?

A: The Program is technology and fuel agnostic, but preference will be given to higher performing (cleaner/lower emissions, more fuel efficient, more durable, more aspirational – all of which could be characterized as more modern for the sake of simplicity) solutions while also taking into account the local context and realities of the market.

Is there an expectation regarding the number of stoves that should be distributed over the duration of the project?

A: There will be different expectations based on the growth stage of the company. For example, if the use of funds for a selected company is just for R&D, the expectations would be different than for a company which is in the growth or expansion stage. The Alliance will work with the selected enterprise to set metric-based milestones to be met during the course of the project.

Q : How long do the projects that the enterprises propose need to be? The Program is expected to be completed by March 2022. Should the joint venture project present the results by that date?

A: A typical project will last for 12 months. However, it can be shorter or longer depending on the specific case. An evaluation of each project will be conducted upon its completion.

Q: Will the funding be spread out or in one installment?

A: The former – the Alliance will disburse funds based on the achievement of milestones to be determined during the scoping and contracting process with selected companies.

Q: How does the mechanism with the potential follow-on funding work? Is there a pre-set timing for it? For example, if we make in the first phase a feasibility study for a local production plant, what would be the timing for a potential follow up?

A: A discussion on follow-on funding will occur after the initial project is completed in a satisfactory way.

Q: Should the products that the companies will distribute be certified?

A: A company selling a product must be willing to test it to be eligible for the Program.

Q: Can you talk more about how testing of stoves could work?

The Alliance will provide testing of stoves and fuels on a no-cost basis to the company and arrange for nearest, accredited testing lab to test any stoves or fuel.

Q: The range of our products is very varied. On what basis will the products being tested be selected?

A: The Program will select products to be tested based on the scope of the project, to be determined in discussion with the enterprise. If the funding is being used to support the commercialization of a particular product, testing may focus on that product. If the funding is being used to support the enterprise as a whole independent of specific products, then perhaps the top two to three selling products of the company will be tested.
